EVENT VENDOR CONTRACT 2022SEASON

Location of Event: Tumbler Ridge Recreation Centre

Dates of Event: Nov 25 & 26th

Cost: See Fee schedule attached to this contract

Vendors are required to submit their entry form and Fees by Nov 15th Cost is \$20 per day or both days for \$30.

Each vendor is allotted 1 table (appx 7').

It is recommended that all Vendors carry liability insurance as Market insurance does not cover individual Vendors.

Vendors must follow all BCCDC and NH protocols and guidelines set out for Community/Farmers Markets/Episodic Markets and that all medium-high risk foods for sale have been produced in government inspected and approved kitchens and have the correct permits/licenses. Low risk foods, such as most baking products, as permitted (please see Northern Health website for list of acceptable low risk foods)

Vendors are responsible to have all Town licences/permits in place if required (ie Food trucks/Commercial Businesses)

All fees are non-refundable as they are used to promote the events and cover operation costs.

Market will be open to the Public 4-8pm Friday night, and 10-4pm Saturday. Set up time on Friday is 3pm and Saturday at 830 am. Set up must be complete no later than 15 minutes prior to opening. Market will provide limited a Security on Friday night and Saturday morning. Vendors will not hold the Market liable for any product left onsite during or after Market hours. Vendors will not disassemble their Booths until after the closing time of each Market.

Vendors are responsible for leaving the area in the same condition as they found it as well as sanitizing their booth and products during the Market as per NH requirements. Vendors will discourage Patrons from handling products in order to reduce the possible spread of Covid-19 and its variants.

We reserve the right to censor any booth and Vendors may not sublet or share booths. Market will provide 1 table per Vendor each day. Vendors that will require additional floor space for free standing displays will limit the display to 1 free standing display no larger than 4ft wide, and shall indicate this additional space request on their application. Additional space will only be allotted pending space availability.
